WTP1 and WTP2 will be upgraded to a modern open-source type SCADA system with remote access capability. The newer WTP3 has a modern system that is not in need of replacement but will need to be integrated with WTP1 and WTP2. The remote radio network is also included as part of the project upgrades.
