



A MESSAGE TO OUR MEMBERS FROM OUR GENERAL MANAGER, CARLOS LIMA

The year 2025 was one of continued growth and achievement for Sharyland Water Supply Corporation. The Corporation expanded both its membership and its infrastructure. For the second consecutive year, membership increased by more than 800 members. To better serve our growing community and improve water distribution efficiency, we upgraded our system by 173,820 linear feet. We also continue to work diligently to secure funding for future improvements that will further strengthen the Corporation's ability to provide reliable service at an affordable rate. Below are additional details highlighting these notable accomplishments. We wish you and your loved ones a happy and safe holiday season.



Funding Achievements

- A \$40 million application for treatment improvements to address forever chemicals that is expected to be 100 percent loan forgiveness has been submitted to the Texas Water Development Board.
- We are currently in the closing process for \$1.05 million in funding that is 70 percent forgivable for new test wells to strengthen our raw water supply.
- Over the past year, the Corporation has successfully obtained \$35 million in funding, including \$10 million in loan forgiveness, to support critical infrastructure and plant improvements.
- We have also been invited to apply for another \$18 million in funding with the potential for up to \$10 million in loan forgiveness to construct a new elevated storage tank that will improve system reliability for our members.

TxDOT Line Relocation Updates

- Completion of Shary Rd. – Mile 5 to Mile 7. Self-performed project with total savings of \$1,400,000.00.
- Ongoing Project Mile 5 – Conway Blvd. to Taylor Rd. Self-performed project with a total projected estimated savings of \$3,000,000.00. Estimated Completion Date of February 2026.

Master Plan Project Updates

- Ongoing Water Treatment Plant 1 Improvements. Opinion of Probable Construction Cost of \$9,122,000.00 to be partially funded by Texas Water Development Board.
- Ongoing Water Treatment Plant 2 Rerate Study. Estimated Evaluation Cost of \$150,000.00
